**RE: CCTV PROPOSAL – Recreation Ground**

Following our recent discussions, please find our CCTV proposal as discussed and detailed below.

We, Turner Security Systems Limited (“the Company”), are a NACOSS Gold (National Approval Council for Security Systems) and BS EN ISO 9001: 2015 approved for the installation and maintenance of intruder alarms. Therefore, we are obliged to carry out our work for you (“the Subscriber”) in accordance with their codes of practice and guidelines.

**PLEASE NOTE THE FOLLOWING IMPORTANT INFORMATION**

- The hard drives located within the recording device, have a 12-month warranty only, the rest of the equipment has a two-year warranty. The hard drives are in use 24 hours a day and worked to full capacity, replacement charges vary on the size of each unit.
- Please note if your service provider defaults your router, or makes any changes to your IP address the remote link with the CCTV will be lost, we would need to visit to re-link the CCTV and this call is chargeable.
- If the broadband/internet fails, the remote link with the CCTV will be lost, but this will reinstate once the broadband/internet connection is restored.
- Please ensure you have your router password ready for our engineer to set up the remote viewing as a further visit could incur additional cost.
- Please note there maybe cost implications if you have restricted broadband with your service provider, our engineer will be able to advise.
- **The hard drive/s located within the recording unit has a 12-month warranty period and the rest of the equipment has a 2-year warranty.**
